## CHILDCARE FUNDING FOR FULL-TIME COURSES AND PART-TIME FURTHER EDUCATION COURSES



Funding is subject to certain qualifying criteria as defined by Scottish Funding Council policies including residence requirements and household income.

This guide offers information for students who would like to apply for assistance with registered childcare costs and fall into the following categories:

- Must have a dependent child
- Must be paying for registered childcare costs to allow attendance at college according to the course timetable and for placement days that are a mandatory part of your course
- A partner must be employed and unavailable to look after children

Child care costs are paid directly to the child care provider and not to the student.

Before applying you should ensure you have claimed for all eligible support that is available to you, such as preschool funding, child tax credits, free local council nursery places, Further Education Bursary funding.

(Please note that your award will only be calculated from the date your application is deemed complete including submission of all the necessary documents).

Higher education students must have applied for all available support from the Student Award Agency Scotland (SAAS) and meet the eligibility criteria for tuition fees.

Higher education students on part-time courses are not eligible to apply to the Childcare Fund for costs but may apply to the Student Discretionary Fund.
